Registration for the event begins at Kern County Gun Club the day of the event: Saturday, November 2nd at 7:00am. For club and general information call 661-765-5818. The Club will be open on Friday for practice. Member rates are charged for tournament shooters.

NSSA Scores

Scores will be submitted to NSSA on each 50 targets shot in each gauge & total for HOA. Ties will be shot-off for event and class champions. Second and third places will be determined by long runs unless cash may awarded due to > 10 shooters in a class.

Entry Fees

All entry fees include NSSA and CSSA fees and a puller/maintenance fee. A \$1 MySkeet per shooter/per tournament fee will be charged.

Concurrent Events

Events 1-5: Honors Only. Champion – Runner-Up and 1-1. Winners will be determined by long runs. Front – back long run ties will be shot off

Shooter Classification

NSSA rules will be followed. It is the shooter's responsibility to ensure that their classification is accurate at registration. Each shooter will receive a printout of their class and events entered at registration. Changes or errors must be brought to the attention of the shoot management at the time of registration. Improperly classified registrants forfeit all awards. HOA Classification cannot be lower than shooter's lowest gun classification. The NSSA app is no longer working. Use your scorecard and keep it up to date.

Shoot information

Practice fields will be available. With the new ammo regulations in CA it is advisable to bring your ammo. NSSA rules apply to this shoot. Kern County Gun Club reserves the right to modify this program without recourse or protest. Notices of any changes will be posted. Official scores and winners will be maintained on the shoot computer. A protest Committee will be appointed and NSSA protest rules apply. Participants and spectators recognize the exposure to potential injury associated with shotgun sports and assume all risks of accidents while attending this event. Ear and eye protection is mandatory for all shooters.

Shoot-Off Policy

All shoot-offs unless otherwise noted will be doubles at stations 3, 4, and 5 miss and out by station. Shoot-offs will be announced with no less than a five-minute call. Any shooter missing his or her shoot-off is considered a "No Show" and forfeits any winnings.

Shooting Times

Each squad is limited to 1 hour and 30 minutes. Please be at the designated field 15 minutes prior to your scheduled shoot time. Squads are encouraged to start early if possible. Since you're shooting two gauges back to back bring all the shells and tubes/guns required.
